By signing below, I agree to the following terms:

1. I agree the dance instructor(s), North Otter Society of Performing Arts and its Directors, employees or facility lessors are not responsible for personal loss or injury while my child is participating in any activities directly or indirectly related to this program. In case such of loss or injury, I agree to indemnify and hold blameless the instructors, Board of Directors, lessors, employees and ancillary staff.
2. Participation in any or all performances will be at the discretion of the dance instructor.
3. I agree to participate and attend all classes, to the best of my ability, recognizing that dance is both an individual and team activity and others rely on my participation to do their work. I understand and agree that attendance at all dress rehearsals and performances is mandatory, unless mutual agreement with class instructor at least 2 months in advance of performances.
4. I understand that a breach of any of these conditions may result in the student being asked to leave North Otter Society of Performing Arts. Should this occur, fees for the current month will be forfeited and subsequent months' postdated cheques will be returned within a 30 day time period.
5. I agree to abide by the class dress code and code of conduct.
6. Any concerns regarding the programs will be directed to the appropriate class instructor first and in the result that a satisfactory conclusion is not achieved, subsequently to the board of directors. Any concerns regarding organization, finances, or registration should be directed to the Board.
7. I also understand that while I am a member in good standing, (defined as no outstanding debts and not in breach of any conditions outlined herein) I am a full voting member of the North Otter Society of Performing Arts, and as such will endeavor to attend annual general meetings and other meetings convened as necessary throughout the year.
8. I agree that in the event of accidental injury all efforts to contact the numbers provided above will be made. I agree that the person(s) named as emergency contact may act as my proxy in care decisions for my child. If no contact is possible, I agree that my child may be transported by ambulance or private vehicle to the closest medical facility as deemed appropriate by the teaching staff. I agree to be responsible for any costs related to such transport or treatment.
